SUMMARY

Offer Price and net proceeds from the Global Offering

- The Offer Price has been determined at HK\$1.80 per Offer Share (exclusive of brokerage of 1.0%, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%).
- Based on the Offer Price of HK\$1.80 per Offer Share, the net proceeds from the Global Offering to be received by the Company, after deducting the underwriting commissions and other estimated expenses payable by the Company in relation to the Global Offering and without taking into account any discretionary incentive fee, is estimated to be approximately HK\$77.7 million. The Company intends to apply such net proceeds in the manner set out in the paragraph headed “Net Proceeds from the Global Offering” below.

Applications under the Hong Kong Public Offering and the Employee Preferential Offering

- The Offer Shares initially offered under the Hong Kong Public Offering have been very significantly over-subscribed. A total of 11,659 valid applications have been received pursuant to the Hong Kong Public Offering on **WHITE** and **YELLOW** Application Forms and through giving **electronic application instructions** to HKSCC via CCASS for a total of 3,033,514,000 Hong Kong Offer Shares, equivalent to approximately 601.9 times of the total number of 5,040,000 Hong Kong Offer Shares initially available for subscription under the Hong Kong Public Offering (excluding 560,000 Hong Kong Offer Shares initially available under the Employee Preferential Offering). The final number of Offer Shares under the Hong Kong Public Offering is 28,000,000 Offer Shares, representing 50% of the total number of Offer Shares initially available under the Global Offering, of which 278,000 Offer Shares have been allocated to the Employee Preferential Offering.
